Official 21st Century Leaders 2009 Vespa Raffle Contest Rules

These Official Raffle Contest Rules apply to the 2009 21st Century Leaders (21CL) Vespa Raffle (the "Raffle").

1. **HOW TO ENTER:** Contest begins June 5, 2009 and ends September 24, 2009 (the "Contest Period").

Purchase a raffle ticket (\$20 each) for the Vespa Scooter during the Contest Period. Raffle tickets are available for sale: (i) from any authorized 21CL event committee member or raffle designee; (ii) from the 21CL office located at 126 New Street, Suite A, Decatur GA 30030; (iii) on the 21CL website at www.21stcenturyleaders.org or (iv) at Celebrating 21st Century Leaders—A Fete at the Foundry (the "Event"), to be held at the Foundry at Puritan Mill in Atlanta, Georgia on September 24, 2009, if unsold raffle tickets are available on that date.

Fill out and submit the tab portion of the ticket to register for your chance to win the Grand Prize Vespa (as described below). Purchasers of raffle tickets must legibly write their names on each raffle ticket (this does not apply to tickets purchased online).

Multiple entries allowed, but only one entry per raffle ticket. Proceeds from the Contest shall go to 21CL for its sole benefit and use.

No more than one name may be stated on the raffle ticket. If more than one name is listed on the ticket, the first name listed shall be considered the "entrant". 21CL shall, will and can have no obligation for delivery to any person other than the entrant.

Retain the raffle ticket stub. In the event of any dispute or controversy concerning the winner of the drawing, you will be required to produce your raffle ticket stub.

2. **ELIGIBILITY:** Contest open to legal residents who are at least 18 years of age or older, with a valid U.S. driver's license, as of the time of the Raffle Ticket purchase. Grand Prize winner must also be able to qualify for auto insurance and be able to receive possession of the Grand Prize in compliance with all applicable laws and regulations, and/or enter into any other contract(s) required in connection with the possession or use of the Grand Prize.

3. **RANDOM DRAWING:** One Vespa Scooter winner will be selected by random drawing to be conducted at the Event on September 24, 2009 by 21CL, whose decisions concerning all matters related to this Contest shall be final. The Contest Winner will be announced during the Event. In the event Contest Winner is not present at the Event, the individual will be notified by telephone and/or email, based on contact information provided by the contestant on his/her entry form.

In the event of a dispute over the owner or holder of a Raffle Ticket stub, the owner of the "winning" entry will be determined by the name and information provided in the entry form. If a winner cannot be reached within fourteen (14) days from the first notification attempt, he/she may be disqualified and an alternate winner selected through a random drawing from the remaining entries. The winner will be required to execute and return an Affidavit of Eligibility and Release and/or other documents required by Sponsor, within a time period to be indicated within such documents.

If any winner fails to comply with these requirements within the time period specified, does not meet the eligibility requirements of these rules, or otherwise does not comply with these rules or accept the Grand Prize, the winner may be disqualified and an alternate winner selected through a random drawing from the remaining entries.

4. **ODDS OF WINNING/GRAND PRIZE/APPROXIMATE RETAILVALUE:** A maximum of 500 Raffle Tickets will be sold. Chances of winning will depend on the number of tickets ultimately sold, but will be no worse than 1:500. There is no limit on the number of tickets which may be purchased by any individual, up to the 500 total being offered.

Provided that 200 or more Vespa Raffle Tickets are purchased during the Contest Period, the Grand Prize will consist of: One (1) “Dragon Red” 2009 Vespa LX 50 (Manufacturer’s Suggested Retail Price \$3,299).

In the event that less than 200 Raffle Tickets are purchased or sold, the Grand Prize Winner will be awarded 50% of the collected proceeds from the Raffle Ticket sales. (For example, if a total of 100 tickets are sold generating \$2,000, Grand Prize Winner shall be awarded a prize of \$1,000). If 200 or more Raffle Tickets are sold, the Grand Prize Winner may not elect cash prize as a substitute.

Regardless of winner’s Grand Prize selection, Grand Prize Winner is and shall be solely responsible for securing and paying all necessary insurance coverage, maintenance, gasoline, and any and all other costs, expenses and fees, including all applicable federal, state and local taxes, title, license, registration and tag fees.
